

RULES & REGULATIONS

PLEASE OBSERVE THE FOLLOWING GUIDELINES FOR THE SAFETY AND ENJOYMENT OF ALL.

QUIET HOURS are 10:00 pm to 7:00 am. Please restrict TVs, stereos, barking dogs and spirited conversation.

LAUNDRY ROOM HOURS are 7:00 am to 9:00 pm.

CHILDREN/SUPERVISION: Know where your children are. Use the "buddy system" always. Any children under 18 must be accompanied by an adult member. No one under 21 may be left in park overnight unsupervised.

PROHIBITED: Firearms and weapons. Motorcycles and ATVs on main roads only.

HOLDING TANKS: No fluid of any kind, gray or black water may be released on ground at any time.

MOTOR VEHICLES: 5 mph speed limit. Yield to horses. children and RVs.

SMOKING: No smoking on trails or in Ghost Mountain Ranch buildings. Smoking is permitted in designated areas only! (Ghost Mountain Ranch Saloon and designated pool area.)

FISHING POND: No rafting, swimming or boating allowed in pond. Catch and release only.

RV HOLDING TANKS: Holding tanks chemicals must be formaldehyde free. Do not drain gray water directly into the ground.

BICYCLES: Helmets required under age 18.

GARBAGE: Use dumpsters for garbage. Please leave

campsite clean after use.

GUEST PRIVILEGES: Primary adult members age 21 or older are permitted quest privileges (day or overnight use), pursuant to membership.

CONDUCT: All visitors to Ghost Mountain are expected to treat others with respect and dignity. All visitors are responsible for the conduct of their family members and guests. Individuals shall not indulge in loud, boisterous or unacceptable behavior while on the premises. Excessive drinking resulting in inappropriate behavior will not be tolerated. Alcohol consumption by minors is prohibited. Any person who willfully or negligently defaces, injures or destroys property belonging to Ghost Mountain or to any individuals, will be held liable for the full value. Any individuals whose actions or behaviors create a situation not in keeping with the expected Ghost Mountain family atmosphere may be instructed to leave the premises by management.

ASSUMPTION OF RISK/LIABILITY OR LIABILITY/IDENTIFICATION:

All members and quests assume responsibility of loss, injury or damage resulting from use of facilities, and indemnify and hold Ghost Mountain, its officers, agents, employees and independent contractors harmless from all claims, damages, suits, expenses, liabilities, injuries and losses.

PET RULES

• All dogs must be on leash.

• Pet owners must clean up after their pets.

• Do not leave pets unattended.

• Pets are not allowed in pool area or in Ghost Mountain buildings.

• Pets are only allowed in pet friendly cabins.

• Noisy or aggressive pets will be removed.



POOL RULES

April through September 9:00 am to 10:00 pm

October through March 9:00 am to 9:00 pm

- Swim at your own risk.
- No lifeguard on duty.
- Obey the posted rules.
- Children under age 14 must be supervised by an adult member 21 years or older.
- Do not use pool area alone.

FIRE RULES

All wood campfires must be contained in a screened, covered fire pit.

EXCEPTION

Propane campfires are always welcome.
